Client agrees to indemnify and hold Artist harmless from any and all claims, liabilities, damages, and expenses arising from any action or activity of Client or Artist while Artist is rendering the contracted services except for claims arising from Artist's willful misconduct or gross negligence. Client may attach a certificate of insurance as proof of coverage. **Cancellation:** In the event that Client cancels any Performance less than five (5) weeks before the date of such Performance, Client will pay Artist, as liquidated damages, one-third of the guaranteed fee. In the event that Client cancels any Performance less than two (2) weeks before the date of such Performance, Client will pay Artist, as liquidated damages, one-half the guaranteed fee agreed to be paid for such Performance.
